Wedding Contract at the CT Renaissance Faire

This Agreement is made effective as of _____, by and between **Susan A. Mead dba. Enjoin Weddings**, 89B Hunters Ave, Taftville, CT 06380; and _____

In this Agreement, the party contracting to provide services shall be referred to as "Wedding Coordinator" and the party who will be receiving the services shall be referred to as "The Bride and Groom".

The Bride and Groom represents that they plan to be married on _____ (date) and they desire to have wedding/event coordination, and related products and services provided by The Wedding Coordinator.

Therefore, the parties agree as follows:

1) DESCRIPTION OF SERVICES: The Wedding Coordinator will provide the following services:

*Package Chosen: Morning vows Harvest union Noble feast Royalty

*Bridal bouquet / Head Wreaths: Yes No bringing own

*Wedding Cake: Yes No bringing own (choices on other sheet)

(b) The wedding couple or agent for the couple agrees to pay an initial non-refundable retainer of \$300.00. This payment serves as a retainer and is due and payable at the time of contract signature and will be applied toward the wedding cost.

(c) Payments may be via cash or check.

(d)The remaining balance is to be paid as follows:

* If paying with a Personal check:
Balance must be **Paid in Full Four (4)** weeks prior to the Event.

* If paying with Cash or Certified Bank Check:
Balance must be **Paid in Full Fourteen (14)** days prior to the Event.

3) DATE CHANGES: In the event the wedding couple is forced to change the date of the wedding every effort will be made by The Wedding Coordinator and staff to support to the new date. The Wedding Couple agrees that in the event of a date change any expenses including but not limited to deposits and fees that are non-refundable and non-transferable are the sole responsibility of The Wedding Couple. The Wedding Couple further understands that last minute changes can impact the quality of the event and that The Wedding Coordinator is not responsible for these compromises in quality.

4) CANCELLATIONS: In the event of a cancellation 14 days or less prior to the event. All payments made to date are non-refundable and all outstanding payments will be due immediately.

5) REMEDIES: In the event The Wedding Coordinator is unable to collect the required payments for any reason the following will apply:

(a) All coordination efforts will cease

(b) All location and sub-contractor reservations made on behalf of The Wedding Couple will be canceled and collection efforts for any remaining debt to The Wedding Coordinator will commence.

6) ENTIRE AGREEMENT: This Agreement contains the entire agreement of the parties. There are no other promises or conditions in any other agreement whether oral or written. This Agreement supersedes any prior written or oral agreement between the parties.

7) AMENDMENT: This Agreement may be modified or amended if the amendment is made in writing and is signed by both parties.

8) SEVERABILITY: If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

9) WAIVER OF CONTRACTUAL RIGHT: The failure of either party to enforce any provision of this Agreement shall not be constructed as a waiver or limitation of that party's right to subsequently enforce and compel strict compliance with every provision of this Agreement.

10) ADDITIONAL TERMS and CONDITIONS: No refunds or rescheduling will be done due to inclement weather unless the FAIRE has to close due to weather conditions. Your wedding time and location may be subject to change in such special weather circumstances.

Fall faire at Hebron, CT. is a **DRY** site. Spring Faire at Guilford, CT. allows alcohol.

Commercial photography, video, and filming activities are conducted at CTRF. You may appear in the resulting pictures or film that may be used in advertising, press releases, entertainment or other CTRF activities. Entry into the park and /or purchase of a ticket constitutes consent for CTRF to use the resulting pictures, videos, and films without compensation to you.

The Bride and Groom agree to comply with all the laws of the USA, the State of CT, the town of Hebron and Hartford County /or the town of Guilford and New Haven County. The Bride and Groom further agree to assume all liability for all damages, theft and /or loss to the Ct Renaissance Faire arising during your event. In addition, the Bride and Groom will defend, indemnify and hold harmless the CT Renaissance Faire, it owners, officers, employees, agents, shareholders and Enjoin Weddings

from any and all liability or damages including reasonable attorney's fees, resulting from claims, demands, costs or judgments arising from or out of any occurrences in, upon, or at the premises, during your event regardless of who asserts such claim.
